GENERAL RULES AND REGULATIONS FOR ALL JR. LIVESTOCK SHOWS

WE ACKNOWLEDGE THE TEXAS ANIMAL HEALTH COMMISSION RULES AND REGULATIONS. FOR A COPY OF THESE RULES CONTACT THE FAIR OFFICE.

NOTICE: All exhibitors are cautioned to read carefully the following rules and regulations as same will be strictly enforced without deviation of any kind.

GENERAL PROVISIONS

THE MONTGOMERY COUNTY FAIR ASSOCIATION RESERVES TO ITS OFFICERS AND/OR BOARD OF DIRECTORS THE FINAL AND ABSOLUTE RIGHT TO INTERPRET THESE RULES AND REGULATIONS AS SET FORTH FROM PAGE 1 TO PAGE 20 AND ARBITRARILY SETTLE AND DETERMINE ALL MATTERS, QUESTIONS AND DIFFERENCES IN REGARD THERETO OR OTHERWISE ARISING OUT OF CONNECTION WITH, OR INCIDENT TO THE SHOW.

The Officers and/or Board of Directors reserves the right to amend, delete and/or add to these rules as they in their judgment, may deem advisable.

In consideration for the opportunity to participate in the Show, each Exhibitor, and his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen and volunteers agree to be bound by the General Rules and Special Rules as published herein. Any exhibitor and his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen or volunteer who violates and/or refuses to follow any of the General Rules and/or Special Rules as published in these rules shall not be allowed to enter, tag-in and/or participate in the Montgomery County Fair, Show and/or Auction, and/or will forfeit all privileges and/or premiums won, and/or may forfeit all rights and privileges to enter, participate and/or exhibit in the future at the Montgomery County Fair.

In order to participate in the Montgomery County Fair, each exhibitor, and his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen and volunteers shall be in good standing with the Montgomery County Fair Association. In the event any exhibitor, exhibitor's immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen or volunteers (whether any of the above individually, or by, through and/or on behalf of any entity) owe money after August 1ST to the Montgomery County Fair Association for any reason whatsoever, said exhibitor, his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen and volunteers shall not be allowed to enter, tag-in and/or participate in the Montgomery County Fair, Show and/or Auction.

THE FOLLOWING RULES AND REGULATIONS FOR ALL JR. LIVESTOCK SHOWS HAVE BEEN ADOPTED BY THE BOARD OF DIRECTORS:

1. The Show will open April 9, 2021 unless postponed and/or canceled by the Officers and/or Board of Directors which they hereby claim the right to do, either in part or whole, due to any cause whatsoever which they determine to be for the general good of all concerned.
2. The Montgomery County Fair Association, its Board of Directors, Officers, Officers-in-Charge, Division Chairmen, Committeemen, etc. will not be liable for any personal injuries, damages, fire, theft, accident and/or any matters resulting from or relating to the actions of any exhibitor, exhibitor's immediate family member(s), parent(s), guardian(s), and/or representative(s), committeemen, volunteers, spectators, visitors, exhibits, animals, animal clinics, forfeiture of all awards and/or sale proceeds, non-payment of sale proceeds by an auction buyer(s), etc.
NOTE: In the event it is determined that the Montgomery County Fair Association is held liable with regard to an exhibitor's animal, whether directly or indirectly relating to same, which liability is specifically denied by the Association, then in that event the limit of the Montgomery County

Fair Association's liability will not exceed the market value of the exhibitor's animal (in its market class and weight) or the animal's tankage price on the date of the Fair Auction Sale, which is hereby acknowledged and agreed to by each exhibitor as a condition of participating in the show.

3. Entrants and Exhibitors must be members in good standing of one of the following:

- 1) FFA – must have attended 50% of local Montgomery County FFA Chapter meetings from September through February.
- 2) 4-H enrolled members must have attended a minimum of three (3) local Montgomery County 4-H Club Meetings from September through February. This does not include project meetings.
- 3) Home Educated Student – must be a member of a Montgomery County 4-H Club and subject to Rule 3.2 above. Only Home Educated Students, whom would have attended a private, public or parochial school within Montgomery County, are eligible to show.

Except as provided in GENERAL EXCEPTION (A) or (B) below, all Entrants and Exhibitors must reside in Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps in Montgomery County five or more nights each week).

GENERAL EXCEPTION (A): Any Entrant or Exhibitor who resides outside Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps outside Montgomery County five or more nights each week), but because of school district boundaries, student is required to attend public school inside Montgomery County; must be a member in good standing and attended a minimum of 50% of club meetings of a Montgomery County 4-H Club or FFA.

GENERAL EXCEPTION (B): Any Entrant or Exhibitor who resides outside Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps outside Montgomery County five or more nights each week), but because parents, parent or legal guardian is employed by a private, public or parochial school district or system in Montgomery County and the Entrant or Exhibitor is enrolled and attending classes in the same private, public or parochial school district or system in Montgomery County; must be a member in good standing and attending a minimum of 50% of club meetings of a Montgomery County 4-H Club or FFA.

Any Entrant or Exhibitor who qualified under GENERAL EXCEPTION (A) or (B) above, may be allowed to participate by completing a Special General Exception Form, but only after official acceptance, which requires approval by the Montgomery County Fair Association. All General Exception Forms are due on the date/time of tag-in of animal exhibitor is showing or a specified date in each division rules.

4. If a student is academically ineligible to show his/her project or show animal, the student and project will not be allowed to show in the Fair.

Substitute Exhibitor: Junior Show animals must be exhibited and sold by its owner.

EXCEPTION: A substitute exhibitor may be used under the following conditions:

- When an exhibitor has more than one entry in the Junior Show and cannot be present to show their animal in another department
- When an exhibitor is sick (must be accompanied by a signed statement from a doctor)
- Approved school activities, TAKS test, etc. (must be accompanied by a signed statement from a school official on school letterhead)

When one of the above conditions exists, the Show Chairmen and Officer-In-Charge may decide whether a substitute showman will be allowed. If a substitute is allowed, the substitute showman must be from the same FFA/4-H as the original exhibitor. The substitute exhibitor also must meet all requirements of a Junior Livestock Show exhibitor. If only one exhibitor is present from the same FFA/4-H, the Show Chairman or Officer-In-Charge can approve a substitute from another FFA/4-H. An exhibitor may be used as a substitute only one time per department. Any exhibitor of a past Grand Champion or Reserve Champion in a respective junior market animal department is NOT eligible to serve as a substitute exhibitor. An official substitute exhibitor form must be filled out and turned in at check-in. The Show Chairman or Officer-In-Charge may also require positive identification of the substitute.

5. Entries must be the bonafide property of the exhibitor.

6. There will be a \$20.00 entry fee on Market Steers, Market Lambs, Market Barrows, Colts, Replacement Heifers, Market Rabbits, Breeding Beef, Poultry and Goats. Exhibitors will receive an armband that entitles them to free entry to the fairgrounds, **April 9 – 11, 2021**. No entries will be accepted by fax. NO REFUNDS FOR ENTRIES. SHOULD AN EXHIBITOR, CEA/VAT OR 4-H MANAGER FAIL TO GET AN ENTRY FORM IN BY THE ENTRY DUE DATE, A LATE FEE OF \$250.00 MAY BE ASSESSED. THE ANIMAL MUST ALREADY HAVE BEEN VALIDATED ON THE ORIGINAL TAG-IN DATE AND HAIR MAY BE PULLED FOR POSITIVE IDENTIFICATION. ALL OTHER RULES MUST HAVE BEEN FOLLOWED.

7. Classification will be done by a classifier(s) selected by the Judges Committee and approved by the Rules Committee.

8. Entries and fee's must be submitted online at mcfa.org by 5:00 p.m. **Friday, February 5, 2021**. Entry fees may be paid for in person at the fair office by 5:00 p.m. **Friday, February 5, 2021**. NO LATE ENTRIES WILL BE ACCEPTED.

9. All animals must stay in the barn from 8:00 p.m. until 6:00 a.m. each night after they are checked in, with the exception of animals checking out immediately following their respective shows. Any exercising or walking of animals will be done in the arena or in the designated exercising area.

10. No Fans will be allowed in the aisles (they can be hanging or placed in feed aisles). No Generators in the Barn.

11. Check out must be approved by the Division Chairman or his representative. All animals must have releases, obtained from Division Chairman or his representative.

- a. Livestock Release forms will require the following information: Exhibitor's Name, Club, Vehicle License Number, Person Picking up Animal, Slaughter Plant Name (if applies), Tag Number of Animal and Parent or Exhibitor's Signature.

12. Division Chairmen have the right to combine classes if insufficient in number and create a class or classes if deemed necessary.

13. Any animal that is to be exhibited in the Junior Livestock Show must be cared for in Montgomery County (EXCEPTION: See General Exception Rule, Page 2). They must be under the daily care of and trained, fitted or dressed for show by the Junior Exhibitor under the direction and assistance from parents, siblings, grandparents or legal guardians; CEA's or VAT's currently residing in Montgomery County; or other feeders or leaders currently residing in Montgomery County. Each Exhibitor and his or her immediate family member(s), parent(s), guardian(s) and/or representative agree that in exchange for participation in the Junior Livestock Show they will allow Montgomery County Fair Association representative(s) permission to enter unannounced onto the property where the Exhibitor's project is located for purposes of inspection.

14. DECISIONS OF CLASSIFIERS AND/OR SIFTERS IN ALL DIVISIONS WILL BE FINAL AT THE TIME OF SUCH CLASSIFICATION AND/OR SIFT, AND PROTESTS WILL NOT BE CONSIDERED BY THE MONTGOMERY COUNTY FAIR ASSOCIATION, AND ALL SIFTED ANIMALS MUST BE REMOVED FROM THE GROUNDS.

15. Committees to inspect/sift livestock may be appointed in such divisions as the Officer-in-Charge and/or Division Chairman deems advisable. It is the duty of the inspection/sifting committee to pass upon the eligibility of animal(s) for show purposes before judging begins. These committees shall be empowered and required to eliminate from entry, tag-in, participation and/or the Show any animal which, in their judgment, is not qualified for competition, and upon the recommendation of the committee, the Officer-in-Charge and/or Division Chairman may require such animal(s) not to be allowed to enter, tag-in and/or participate in the Montgomery County Fair, Show and/or Auction, and/or to be removed from the show grounds.

16. The Officer-in-Charge and/or Division Chairman reserve the right not to allow entry, tag-in, participation, and/or to remove from the grounds any exhibit, animal, stand or show they deem unsuitable or objectionable. No wild or unruly animals will be accepted. The Officers and/or Executive Committee also reserve the right to return any entry money already paid. Officer-in-Charge and/or Division Chairman will not be required to furnish reasons for such actions, the return of the exhibitor's and/or purchaser's money exonerates the association from any claim by the exhibitor or purchaser.

17. Each exhibitor and his/her immediate family member(s), exhibitor's guardian(s), parent(s) and/or representative(s), committeemen, volunteers, spectators and/or visitors, violating and/or not cooperating with security personnel, officers, Officer-in-Charge, Division Chairmen, committeemen and/or officials of the Fair in all matters, policy, these rules and regulations, parking, laws of the State of Texas, etc., may not be allowed to enter, tag-in, and/or participate, may have their entries cancelled, and/or may be ordered to exit and/or remove their exhibit(s) from the grounds immediately, and/or may forfeit all rights and privileges to enter, participate and/or exhibit in the future at the Montgomery County Fair.

18. **Animal/Exhibitor Disqualification:** To foster fair competition, to provide a level playing field, and to protect the safety of food, the showing of unethically fitted livestock, livestock of any ineligible age for exhibition in the class entered or animals being administered unapproved drugs is strictly prohibited.

- A. **Unethical Fitting:** Unethical fitting means any attempt to alter the natural appearance, conformation, musculature or weight of an animal by any unnatural means. Unethical fitting includes the use of injections or feeding of material not conducive to the health of the animal, safety of food or marketability of its carcass. Unethical fitting also includes, but is not limited to, airing injections and bruising. Animals showing signs of having been unethically fitted may be disqualified.
- B. **Over Age Animals:** Over age animals will be disqualified.
- C. **Illegal Use of Unapproved Drugs:** The showing of any animal that has been administered during its life any quantity of any unapproved drug, chemical or medication is strictly prohibited. Such drugs include, but are not limited to, any diuretic, unapproved growth stimulant or other unapproved medication. Unapproved means not approved by the Food Drug Administration (FDA) and/or the U.S. Department of Agriculture (USDA) for slaughter animals including animals that may be destined for human consumption. Use of unapproved drugs is illegal by violation of federal law.
- D. **Legal Use of Approved Drugs:** If any approved drug has been administered to the animal, sufficient time must have passed so that the animal does not test positive for any drugs or chemicals at weigh in and/or check-in.

E. Animal inspection: As condition for participation in the Show, exhibitor must agree to submit any animal entered by the exhibitor for inspection. Exhibitor agrees to have such animal submitted to any tests requested by the Show. Exhibitor also agrees that the opinion reached by the Show or its officials as to whether such animal is unethically fitted or over age shall be final and binding without recourse against the Show or any of its officers. Further, the Show specifically reserves the right to have tissue, blood or urine laboratory analysis made on any animal entered for competition. The conclusions reached by the laboratory as to whether such animal has been administered a diuretic, unapproved growth stimulant or other unapproved medication, or has not been properly withdrawn from approved drugs shall be final and binding without recourse against the Show or any of its officers. An exhibitor of an animal testing positive for any drug or medication or unapproved chemical may forfeit all rights and privileges to exhibit livestock in the future at the Show.

F. Extra-Label Use of Drugs: The use by non-veterinarians of animal drugs or other substances in any manner other than in accord with the labeling approved by FDA is extra-label drug use and is illegal by violation of federal law. Exhibitor and exhibitor's parents and/or guardians agree that: (1) they are absolutely responsible persons for the care and custody of their animals (2) the Montgomery County Fair Association shall be entitled to disqualify an exhibitor whose animal tests positive for any drug, even if the exhibitor and the exhibitor's parents or guardians are innocent of any wrongdoing and did not administer the drug, and (3) the drug test results of the testing laboratories are final and binding upon the exhibitor and exhibitor's parents and/or guardians. Even if the source of the drug is unknown, the Montgomery County Fair Association shall be entitled to disqualify the exhibitor.

*Abuse of the extra-label drug use privilege or non-compliance of FDA extra-label drug use policy by veterinarians is illegal by violation of federal law and is subject to serious consequences such as license revocation by the State Board of Veterinary Medical Examiners.

19. All Junior Market Animals will be required to have a drug certification form signed by the following:

- 1) JUNIOR EXHIBITOR
- 2) PARENT OR GUARDIAN; AND
- 3) CEA OR VAT

This form MUST be brought to the Show and given to the Show Officials by the exhibitor at the time that the market animals are checked-in. NO junior market animal will be allowed to show without this drug certification form properly filled out.

20. All protests to any ruling and/or to any provision of these rules and regulations set forth from Page 3 to Page 32 must be in writing and be accompanied by a deposit of \$50.00 which will be forfeited if protest is not sustained. Such protest must state plainly the cause of complaint or appeal, and must be delivered to the Fair Office and notice given to the Officer-in-Charge and/or Division Chairman immediately after occasion for such protest. Protests will be accepted prior to judging. Judging procedures will not be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until complete investigation is done. All protests will be determined by a special committee made up of five members consisting of the Officer-in-Charge, Division Chairman, and three other members from the rules committee and/or Board of Directors. Every exhibitor, in consideration of his entry being accepted by the Montgomery County Fair Association, agrees that the conclusion reached by the protest special committee shall be final, without recourse against the Montgomery County Fair Association, its Board of Directors, Officer-in-Charge, Division Chairmen, Committeemen, etc. (See General Provisions set forth on Page 3).

21. Exhibitors from the same immediate family will be able to tag in their animals, of the same species, without specifying which animal belongs to which exhibitor in the immediate family, however, each child's name must be listed on each tag-in card. THERE MUST BE AS MANY ANIMALS, OF THE SAME SPECIES, AS THERE ARE EXHIBITORS (EX. THREE CHILDREN IN THE FAMILY – THERE MUST BE AT LEAST THREE ANIMALS OF THE SAME SPECIES TAGGED IN). The tag number of the animal they will show will be determined at the time of weigh-in. If two animals of the same species are tagged in, the first animal weighed will be the animal that is shown.

22. No scales except the official scales will be permitted on the grounds. No trailer parking will be permitted on the grounds, except designated area.

23. Ages for Showmanship will be Junior - 13 and under and Senior - 14 and over. Ages will be based on age the day of the show.

24. ANY EXHIBITOR WITH ANY SPECIAL NEEDS OR CONCERNS MUST PROVIDE WRITTEN NOTICE OF SAME TO THE FAIR OFFICE NO LATER THAN TWO (2) WEEKS BEFORE THE FAIR EVENT BEGINS SO THAT APPROPRIATE ARRANGEMENTS, IF ANY, CAN BE CONSIDERED.

25. ANIMAL HANDLING DEVICES: Show Management or Livestock Officer In Charge/Committee Chairmen reserve the right to decide what constitutes acceptable show equipment and how the equipment is being used by the exhibitor. **CABLE HALTERS ARE PROHIBITED FOR ALL SPECIES.**

GENERAL RULES AND REGULATIONS LIVESTOCK AUCTION

1. The Auction is a continuation of the Montgomery County Fair, and all general and Division Rules and Regulations shall apply.
2. Grand and Reserve animals will sell first in the auction.
3. It is expected that **approximately** 23 steers, 42 hogs, 20 pens of broilers, 10 pens of rabbits, 20 lambs, 15 goats and 5 turkeys will be sold in the Auction; however, the exact number will be determined by the Executive Committee and the Auction Chairman. For those divisions selling more than 23 animals, only the top 23 exhibitors will be allowed to bring their own animal into the sale ring. A sale ring animal will be provided for all remaining exhibitors.
4. No distressed items will be sold.
5. There will be no resale of animals back to the exhibitor.
6. A place for buyers will be reserved at the Auction.
7. At the end of the Auction all animals must be taken back to the stalls in the show barn. Each contestant must fill out a receipt of delivery stating the wishes of the buyer. The youth will be responsible to see that the animal is maintained and delivered to the buyer on the specified date. Any youth who fails to comply with the feeding and care of the animal will never be allowed to participate in the show again. **ALL SALE ANIMALS MUST BE CHECKED OUT BY 10:00 A.M. ON THURSDAY MORNING FOLLOWING THE AUCTION. FAILURE TO DO SO MAY RESULT IN PREMIUM MONIES BEING FORFEITED.**
8. Junior Exhibitors who **have** a Grand Champion in the Livestock Show at the **2021** Montgomery County Fair will not be eligible to compete in that division for the **2022** Montgomery County Fair in which their Grand Champion was exhibited. (This includes substitution roles – See Rule 4, Page 2). This rule applies to all Junior Exhibitor Divisions in which Exhibitors are competing to make the respective auction sales. Exception: If an Exhibitor has 2 grand animals and he drops one, he will be able to show the following year in the division he dropped.
9. If an Exhibitor drops a Grand or Reserve Auction item to sell another Grand or Reserve Auction item, no changes will be made in the placement of other animals or poultry.
10. At the Sale Meeting following each show, the Exhibitor must be in attendance. Montgomery County 4-H Managers and Montgomery County FFA Advisors should be in attendance. A parent of each Exhibitor is encouraged to attend. All alternates should try and attend the sale meeting after the Market Steer Show. Contestants are eligible to enter each Division of the Show, however, each exhibitor may sell only one entry in the Auction. **AN EXHIBITOR PLACING MORE THAN ONE ANIMAL IN THE SALE MUST NOTIFY THE FAIR OFFICE IMMEDIATELY FOLLOWING THE SHOW IN WHICH THEY HAVE PLACED THE SECOND ANIMAL INFORMING THEM WHICH ANIMAL TO PLACE IN THE SALE.**
11. IT IS MANDATORY THAT THE EXHIBITOR BRING THE RECEIPT OF DELIVERY, SOCIAL SECURITY NUMBER, AND ORIGINAL THANK YOU LETTER(S) TO THEIR BUYER(S) TO THE FAIR OFFICE WHEN **CHECKS ARE RELEASED ON TUESDAY, MAY 25-2021**. FOREIGN EXCHANGE STUDENTS MUST ALSO HAVE A SOCIAL SECURITY NUMBER OR A TAX I.D. NUMBER BEFORE CHECK WILL BE RELEASED. THE FAIR OFFICE WILL MAIL THANK YOU LETTERS AND BUYER'S PICTURE. PARENTS AND/OR EXHIBITOR ONLY MAY PICK UP CHECKS. **ALL CHECKS MUST BE PICKED UP BY MONDAY, JUNE 7-2021 BY 5:00 P.M. CHECKS NOT PICKED UP BY JUNE 7TH WILL BE FORFEITED AND THE MONIES WILL GO DIRECTLY TO THE FAIR SCHOLARSHIP FUND.**

12. Ten percent (10%) will be deducted from the Exhibitor's check for any and all monies received through the Fair Association. In addition, cost of pictures will be deducted from the Exhibitor's check.

13. Should a family member purchase their own child's (whether by blood, marriage, adoption, foster child, exchange student, grandchild, ward, etc.) animal, said animal must be paid for before the exhibitor will receive his/her check from the Fair Office.

14. If an exhibitor is not present to sell his/her animal, the animal will be dropped from the sale.

15. The animal that makes the auction is the animal that is sold to buyer and delivered to buyer.

Verification of Quality Counts is a natural extension of this effort to demonstrate that 4-H and FFA youth have a base knowledge of the principles of quality assurance and good moral character.

Now and in the near future many local and major livestock shows will require that a youth exhibitor demonstrate this base knowledge by taking the online Quality Counts Verification test and obtaining a Verification Number. The Montgomery County Fair will be requiring the Quality Counts Certification and the Certification number must be written on your entry form when turned in to your 4-H and FFA Leader.

1. This division is subject to the General Rules and these Division rules.
2. Open to all 4-H and FFA members that are enrolled in public, private, parochial schools or Home Educated students. If an exhibitor requires a General Exception Form (refer to Page 2), it will be due on January 12, 2021. Each application will be reviewed for compliance.
3. There will be a validation held for the Breeding Beef Division for Montgomery County Fair on January 12, 2021 from 2PM – 7PM at the Montgomery County Fair Office, where original registration papers for all registered heifers or a Bill of Sale for only heifers validated for Montgomery County Fair Replacement Heifer Show will be processed. **Exhibitor is required to bring original Registration paper/papers or Bill of Sale for Montgomery County Fair Replacement Heifer Show and two copies of said papers to verify eligibility at this time.** Exhibitor must present ALL papers of ALL heifers he or she is planning to exhibit at the Breeding Beef Show at the Montgomery County Fair. There will be no substitutions. Papers will be checked by Montgomery County Breeding Beef Committee. Exhibitor should be present. Parent or guardian MUST be present to sign validation card. Heifers will not need to be present; this is a paper validation only. Committee has the right to check tattoo numbers in ear at time of Show. All validated Montgomery County Fair Replacement Heifers and Montgomery County Fair Scramble Heifers MUST present Registration papers or Bill of Sale at this validation to exhibit their heifer in the Montgomery County Fair Breeding Beef Show.
4. Grand and Reserve banners will be awarded to overall show winners. Grand and Reserve Belt Buckles will be awarded to division winners. Showmanship jackets will be awarded. Rosettes will be given to Champion and Reserve Breed Champions.
 - a. All others will receive ribbons.
 - b. The Fair Association will contribute \$1500 to prize money and have a 60/40 payback on entry fees. (The 60% will go to the exhibitors, 40% to the Fair).
 - c. If only one entry in a class, 2nd place prize money will be awarded.
5. **Breeding beef heifers showing only in the Breeding Beef Show MUST be registered in the Herd-book of their Association in ONLY the name of the junior owner on or before November 10 of the year preceding the show. Purchase date, delivery date, possession date, transfer date and registration date must all take place on or before November 10 of the year preceding the show.**
6. No grooming material is allowed. This is a "Blow and Go" Show. All heifers will be shown with hair in a natural state WITHOUT the use of glues, adhesives, paints, etc. Heifers with any type of glue, paint, adhesive, etc. in the hair will be disqualified and premiums forfeited. Heifers will be toweled.
7. Stomach pumping, drenching tubes or any other method (by esophagus) is prohibited.
8. All breeding stock must be double-tied.
9. No bedding hay.
10. Judging will be done in the following order:

AMERICAN DIVISION – Brahman, Brahmousin, Brangus/Red Brangus, Beefmaster, Santa Gertrudis, Simbrah , ABC and ARB. The first and second place of each breed will be called back to choose the Grand and Reserve of the American Division.

ENGLISH DIVISION – Angus/Red Angus, Hereford/Polled Hereford and Shorthorn. The first and second place of each breed will be called back to choose the Grand and Reserve of the English Division.

EXOTIC DIVISION – Charolais, Chianina, Maine Anjou, Simmental, ORB and AOB. The first and second place of each breed will be called back to choose the Grand and Reserve of the Exotic Division.

MINIATURE CLASS – Any breed as specified above under the American, English and Exotic Divisions.

Maximum height for Miniature Class is 45" on mature females. All entries will be measured for height prior to showing. Designated Show officials will conduct all height measurements. Those exceeding the 45" height requirement will not be allowed to compete in the Miniature Class.

Breeds will be broken down into the following classes:

CLASS 1: BORN AFTER 10/1/2020

CLASS 2: 6/1/2020 – 9/30/2020

CLASS 3: 2/1/2020 – 5/31/2020

*5 or more entered will determine breed assembly at the discretion of the Show Chairman and/or Officer in Charge.

10. Entries must be completed and paid by **Friday, February 5, 2021 at 5:00PM**. Entry fee is \$20/hd.

11. Breeding beef entries will be released immediately following the breeding beef show on **Sunday, April 11, 2021**.

12. There will be one stall assigned per entry (heifer). Said entry (heifer) and exhibitor has right of occupancy and/or use of only the single assigned stall space. The Committee reserves the right to police stalls at any time to determine if any non-assigned stall space should be filled. Exceptions to this rule will be considered on a case by case basis to be determined by the Chairman.

RULES FOR 2021 SCRAMBLE SHOW EXHIBITORS:

1. This division is subject to the General Rules and these Division rules. If an exhibitor requires a General Exception Form (refer to Page 2), it will be due on January 12, 2021. Each application will be reviewed for compliance.
2. No grooming material is allowed. This is a "Blow and Go" Show. All heifers will be shown with hair in a natural state WITHOUT the use of glues, adhesives, paints, etc. Heifers with any type of glue, paint, adhesive, etc. in the hair will be disqualified and premiums forfeited. Heifers will be toweled.
3. Stomach pumping, drench tubes or any other method (by esophagus) is prohibited.
4. The breed categories will consist of:
 - a. American
 - b. English
 - c. Exotic
5. An online entry is required, but there is no entry fee for the Scramble Calf Show. If you wish to enter the Breeding Beef Show and/or Replacement Heifer Show, entry will need to be submitted online and entry fees of \$20.00 for each show will be charged. Scramble calves may participate in the Replacement Heifer Show & Sale but will have to tag in on October 6th. Scramble Heifers may participate in the Breeding Beef Show but will have to validate on January 12th. All rules for the Breeding Beef Show and Replacement Heifer Show and Sale will apply (if applicable, refer to these rules for show requirements).
6. Entries must be completed by Friday, February 5, 2021 at 5:00PM.
7. All Breeding Stock must be double-tied.
8. No bedding hay.
9. With regard to Calf Scramble Show placement:
 - a. Belt buckles will be given to Grand and Reserve Champion of Show
 - b. Rosettes will be given to Grand and Reserve Champion of Breeds
 - c. All others will receive ribbons
10. The following scholarship money will be given:
 - A. \$3,000.00 for First Place overall;
 - B. \$2,000.00 for Second Place overall; and
 - C. \$1,000.00 for Third Place overall

Exhibitors will be judged to determine overall placement as follows: 10% - Calf Placement in Show; 30% - Presentation of Heifer and Personal Interview and 60% - Essays and Monthly Reports. The overall placement may be determined by the following weighted factors, including but not limited to: Completeness, Neatness, Accuracy, Timeliness and Comments of Monthly Progress Reports, Photographs; Sportsmanship; Presentation of Heifer and Personal Interview; Calf Scramble Show; Essays; Scrapbook; and Showmanship. The scholarship money will be funded directly to the college, University or institution of higher learning of the exhibitor's choice upon satisfactory proof of enrollment.

11. Once each month, the exhibitor will be required to make a progress report on their animal. The reports are marked late if they arrive at the Fair Office after the 10th of each month. They are due by 5:00 p.m. No faxes will be accepted. Should the 10th fall on a Saturday or Sunday, the reports will be due the following Monday. Monthly progress reports must be submitted to the Montgomery County Fair Association Office, the sponsors, and the exhibitors CEA or VAT. By February 1, 2021, by 5:00 p.m., exhibitors must submit a 1500-word essay on "MY BEEF CALF SCRAMBLE PROJECT". By November 1, 2020, by 5:00 p.m., exhibitors must submit a 500-word essay on "WHY I SELECTED A (BREED) FOR MY SCRAMBLE PROJECT."

12. Scramble exhibitors who **SUCCESSFULLY** complete all phases of their project to the satisfaction of the Committee Leadership and the Fair Association will be awarded \$250.00 at the completion of all Fair activities. Successful completion includes compliance with all requirement set forth in the MCFA Official Rule Book including Calf Scramble Division Rules. The timely submission of all required monthly reports, scrapbook, 500 & 1500-word essay's and exhibiting the heifer at next year's fair will be confirmed as part of the committee's decision to determine award eligibility. The decision of the Committee Leadership and the Fair Association is final. This reward check will be mailed to the exhibitor after the Fair.

RULES THAT APPLY TO 2021 SCRAMBLERS:

1. Open to all 4-H and FFA members that are enrolled in public, private, parochial schools or Home Educated Students. Even if an exhibitor has been through the program once, they are eligible to participate in the program again, but only after they have sat out of the program for the year following their participation. They would then be placed at the bottom of the list giving exhibitors who have not participated in the program an opportunity to do so.

2. Participants must have reached their 12th, but not their 18th birthday on January 1, 2021, and not be enrolled beyond their junior year in high school. Participants must weigh at least 100 pounds. Selection of Calf Scramble participants will be done through the 4-H and FFA.

3. Heifers MUST BE PURCHASED BY EXHIBITORS NO LATER THAN SEPTEMBER 1ST, following the 2021 Show. Payment on scramble certificates will not be made to the seller until transferred Registration Certificate and health papers, properly completed by a licensed veterinarian, and received in the Fair Office. Registration certificates must be transferred and/or recorded in the exhibitor's name on or before November 1, 2021. Scramble heifer must be under the daily care of the exhibitor by Replacement Heifer tag-in.

4. Heifer must be purebred and registered in the Association records of one of the following breeds: ARB, ORB, Beefmaster, Brahman, Brangus, Red Brangus, Santa Gertrudis, Simbrah, Angus, Hereford/Polled Hereford, Red Angus, Shorthorn, Charolais, Limousin, Maine Anjou and Simmental.

5. If you are awarded a calf in the 2021 Scramble, the calf you select to show in the 2022 show must have been born between JULY 1, 2020 and MARCH 31, 2021.

6. Should any participant in the Calf Scramble fail to catch a calf because of unusual or extenuating circumstances and is then awarded a heifer by some member of the audience or hard luck sponsor, said participant will participate in all events offered to the scramble exhibitors. The exhibitor must care for the heifer under the Calf Scramble Rules and the donor will become a Calf Scramble Sponsor.

7. Scramble catchers ARE REQUIRED to exhibit their heifer at the 2022 Montgomery County Fair. Exceptions will be considered by the Officer-In-Charge and the Chairman on a case by case basis. The original registration papers will be mailed approximately two weeks after the heifers have been shown. Failure of an exhibitor to participate and exhibit their heifer at the 2022 Montgomery County Fair may result in the exhibitor being required to refund all scramble certificate monies to the Montgomery County Fair Association, exceptions will be considered by the Officer-In-Charge and the Chairman on a case by case basis; the original registration papers will not be mailed to the exhibitor until said monies have been refunded to the Montgomery County Fair Association, and the above is hereby acknowledged and agreed to by the exhibitor

as a condition of participating in the calf scramble program, and/or may forfeit all rights and privileges to enter, participate and/or exhibit in the future at the Montgomery County Fair.

8. Sponsors are obtained for the exhibitors and a purchase certificate not to exceed \$1,750 will be made out to the seller of the calf. Scramble exhibitors who **SUCCESSFULLY** complete all phases of their project to the satisfaction of the Committee Leadership and the Fair Association will be awarded \$250.00 at the completion of all Fair activities. Successful completion includes compliance with all requirements set forth in the MCFA Official Rule Book including Calf Scramble Division Rules. The timely submission of all required monthly reports, scrapbook, 500 & 1500-word essays and exhibiting the heifer at next year's fair will be confirmed as part of the committee's decision to determine award eligibility. The decision of the Committee Leadership and the Fair Association is final. This reward check will be mailed to the exhibitor after the Fair.

9. A MEETING WILL BE SCHEDULED IN MAY IN ORDER TO PICK UP CALF SCRAMBLE CERTIFICATES. A thank you note to the sponsor MUST be turned in at this time and payment will be due also at this time for (2) scramble pictures. The Fair Office will mail the thank you note along with one picture to the sponsor.

1. This division is subject to the General Rules and these Division Rules.
2. All Market Steers to be entered and eligible to show must be the property of the exhibitor, on feed and under the daily care of the exhibitor by September 15, 2020. Each exhibitor can nose print and register two (2) animals, but may only show one. Exhibitor must present a LEGIBLE color photograph of himself and the Steer at the time of registration. **No late pictures will be accepted.** Registration will be held on September 15, 2020 from 4:00 p.m. until 7:00 p.m. Steers will be nose printed by Montgomery County Steer Validation Committee. DNA samples will be collected for positive identification. Exhibitors should be present. A parent or guardian **MUST** be present in order to sign tag-in cards and hair sample envelope. If an exhibitor requires a General Exception Form (refer to Page 2), it will be due on the date/time of tag-in of animal exhibitor is showing. Each application will be reviewed for compliance.
3. All Steers must have official tag on at time of weigh-in at the Fair. If you should lose your tag, contact the Fair Office at (936) 760-3631.
4. Determination of steer's classification is to be based upon predominant breed characteristics. **Final classification will be conducted by a classifier or classification committee at the date of registration.**
5. Steers must be dehorned, otherwise they will not be accepted in the Show.
6. Any Steer showing live testicular tissue will be sifted.
7. Steers must weigh a minimum of 900 lbs. when weighed in. Steers will be weighed one time only and that weight will be the official weight.
8. Following completion of placing, the judge will place the sale order of the steers.
9. Steers selected for sale order will be branded on the right jaw by show officials at time of selection of sale order.
10. Champion and Reserve Champion Steer of each breed classification shall return to the judging arena for selection of the grand and reserve champion of the show.
11. Unethical fitting is prohibited including, but not limited to the following:
 - a) No change of the natural color pattern of the animal by painting or dyeing will be allowed.
 - b) Any grooming material that allows color to come off from any animal will not be allowed at the show.
 - c) The addition of any dust, hair or hair like substances, including, but not limited to false tail heads and false polls. False tail switches are allowed.
 - d) The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue in an attempt to alter the shape of the animal.
 - e) The injection of any natural or synthetic air or gas, solid or liquid under the hide to alter the normal conformation.
 - f) Stomach pumping, use of drenching tubes or any other method (by esophagus) is prohibited.

Clipping: Prior to arrival at the Show, steers must be pre-clipped to no more than 1/4" of hair on any part of the body, except the tail switch, which may be ratted and balled or may be bobbed off. Only scissors or cordless clippers may be used for touch-up prior to entering

the scales. Steers will be checked for hair length at the time of weigh in at the show. Steers found in violation of this rule will be eliminated and removed. The exhibitor will be eliminated from competition for the current show in the steer division. 1/4" hair requirement will be strictly enforced.

12. No bedding hay.

13. All animals must be double-tied.

14. Parents or other adults will not be allowed to assist the junior exhibitors during judging.

15. Any Breed may, at the discretion of the Division Chairman, be divided into light, medium and/or heavy classes according to weights at the Show.

16. The following is a list of Breeds and the order in which they will be judged:

Each exhibitor can tag and register two (2) animals but may only show one. Exhibitor must present a LEGIBLE color photograph of himself and the Barrow at the time of registration, which will be held on January 5, 2021 from 2:00 p.m. – 7:00 p.m. No late pictures will be accepted. Exhibitors are responsible for having their barrows ear notched prior to tag-in. Ear notch and tag-in cards will be sent to FFA and 4-H groups before the tag-in and ear notches should be marked, and cards filled out before you get to the Fairgrounds. Ear notches will be checked by a committee member. DNA will be collected for positive identification. Exhibitors should be present. A parent or guardian MUST be present in order to sign hair sample envelope. If an exhibitor requires a General Exception Form (refer to Page 2), it will be due on the date/time of tag in of animal exhibitor is showing. Each application will be reviewed for compliance.
3. All Barrows must have official tags on at the time of weigh-in at the Fair. If you should lose one tag, contact the Fair Office at (936) 760-3631. A fee of \$300.00 will be assessed should a barrow lose both ear tags and it is determined that DNA testing is required for proper identification.
4. Determination of Barrow's classification is to be based upon predominant breed characteristics which indicate that the subject animal has the required blood relating to the class to which it is entered. Final classification will be conducted by a classifier or classification committee at time of weigh-in.
5. Any barrow showing live testicular tissue will be sifted.
6. Barrows will be divided into weight classes after check-in. Barrows shall not weigh less than 230 pounds and not more than 280 pounds. Barrows will be weighed one time only and that weight will be the official weight.
7. Any Breed may, at the discretion of the Division Chairman, be divided into appropriate subdivisions according to weights at the show.
8. The following is a list of Barrow Breeds and the order in which they will be judged:
Breed 1 – Duroc
Breed 2 – Other Purebreds
Breed 3 - Hampshire
Breed 4 - Crossbred
9. Following completion of breed placing, the judge will place the sale order of the Barrows.
10. The Champion and Reserve Champion Barrow of each breed classification shall return to the judging arena for selection of the Grand and Reserve Champion of the Show.
11. No bedding hay.
12. Unethical fitting is prohibited including, but not limited to the following:
 - a) No change of the natural color pattern of the animal by painting or dyeing will be allowed.
 - b) Any grooming material that allows color to come off from any animal will not be allowed at the show.

- c) The addition of any dust, dry soap, hair or hair like substances.
- d) The cutting, tearing or gluing of the hide or underneath the hide or removal of tissue in an attempt to alter the shape of the animal.
- e) The injection of any natural or synthetic air or gas, solid or liquid under the hide to alter the normal conformation.
- f) No oil, paint, powder or other dressing will be permitted on swine. (ONLY WATER IS PERMITTED).

13. The use of drugs not approved for swine used for human consumption will not be allowed.

14. HOGS WILL BE RELEASED THE MORNING FOLLOWING THE SHOW. ALL HOGS MUST BE CHECKED OUT BY 12:00 NOON. ALL SALE ANIMALS MUST BE CHECKED OUT BY 10:00 A.M. ON THURSDAY MORNING FOLLOWING THE AUCTION. FAILURE TO DO SO MAY RESULT IN PREMIUM MONIES BEING FORFEITED. RELEASE FORMS WILL BE COMPLETED AND GIVEN TO THE EXHIBITOR, PARENT, AG TEACHER OR 4-H LEADER AT THE TIME OF WEIGH-IN OR WHEN THE EXHIBITOR IS GIVEN THEIR EXHIBITOR NUMBER.

6. All Lambs, with the exception of Southdown's, must weigh a minimum of 90 pounds. Southdown Lambs must weigh a minimum of 80 pounds. There is no maximum weight limit placed on Lambs. When an exhibitor presents his Lamb to be weighed, it is understood that the weight will be recorded and become official. Each Lamb will be weighed one time only.
7. Any Lamb showing live testicular tissue of excessive Ram characteristics will be sifted.
8. All Lambs must be slick shorn from knee and hock up at the time of show. All exhibitors will be responsible for the shearing of their own Lamb.
9. Haltered or collared Lambs will be permitted in the show arena.
10. The Champion and Reserve Champion Lamb of each breed classification will be eligible to compete and shall return to the judging arena for selection of the Grand and Reserve Champion of the Show.

14. Lambs will be secured at night by exhibitor.

15. Classes will be established for each breed and set by weight. The number of classes and animals per class will be at the discretion of the Lamb Committee Chairman.

5. All heifers must be brucellosis calf hood vaccinated by the initial weigh-in on **October 6th**. They must have a tattoo and the exhibitor may bring vaccination papers with them. Heifers must be de-horned **BEFORE** weigh-in on **October 6th**.
6. No grooming material is allowed. This is a "Blow and Go" Show. All heifers will be shown with hair in a natural state WITHOUT the use of glues, adhesives, paints, etc. Heifers with any type of glue, paint, adhesive, etc. in the hair will be disqualified and premiums forfeited. Heifers will be toweled.
7. Stomach pumping, drenching tubes or any other method (by esophagus) is prohibited.
8. The following age heifers will be eligible to show: Heifers born July 1, **2019** – March 31, **2020**.
9. Classes will be broken by weights and number of classes will be determined per number of entries.
10. Additional program dates will be set and exhibitors will be notified.
11. Heifers will be weighed in for the Fair on **April 15th**, beginning at **8:15 a.m.** Heifers will be weighed one time only and that weight will be the official weight.
12. If heifers are to be sold as registered, registration papers must be in the exhibitor's name and turned in to the chairman prior to the show.
13. The Show will open April 15, 2021 unless postponed and/or canceled by the Officers and/or Board of Directors which they hereby claim the right to do, either in part or whole, due to any cause whatsoever which they determine to be for the general good of all concerned.

FOR RECORDBOOK COMPLETION AND SUBMISSION:

14. Exhibitors will be required to complete all aspects of the Replacement Heifer Project to be eligible to sell their animal. Exhibitors will be judged as follows: 25% on record book and project closeout summary, 25% on interview, 25% on test and 25% on calf placement in show.

15. To complete the record book and closeout summary, the exhibitors must weigh back their heifer prior to closeout date of **March 19, 2021**; ending weight MUST be documented in the closeout summary.

16. Record book and closeout summary sheet completion is required BY **MARCH 19TH**. The record book with completed closeout summary sheet is due in the Fair Office on **MARCH 22ND BY 5PM – via email in PDF Format to kiah@mcfa.org**. NO LATE ENTRIES WILL BE ACCEPTED, nor will items placed in the drop box be accepted.

17. The summary sheet will be used by the judges to conduct interviews on **Saturday MARCH 27TH**. NOTE: All interviews and testing will be completed on the same day and all exhibitors must participate in BOTH to be eligible to sell their heifer.

FOR AWARDS, SALE PROCEDURES AND RULES

18. Ribbons will be awarded 1st through 10th places. A Grand and Reserve Banner will be given at the Heifer Show and to the overall winners. A Showmanship award will be given.

19. All heifers must sell on Thursday. Cattle will sell beginning with Grand through 10th Place. All others will be drawn at random. Any heifer weighing in at 700 lbs. or less **will not be able to show or sell.** A 5% sales fee will be deducted from each sale.

HEIFERS THAT ARE TO BE REPRESENTED AS PREGNANT AT THE TIME OF SALE, MUST BE ACCOMPANIED BY A WRITTEN STATEMENT FROM A VETERINARIAN THAT THE HEIFER HAS BEEN PALPATED AND A PREGNANCY EXAM PERFORMED VERIFYING SAID PREGNANCY.

20. All heifers will be released after the sale by the Committee.

21. In order to comply with the national law on the beef check-off, two dollars (\$2.00) will be deducted from the sale price of each heifer.

22. All heifers entered in this program and sold become property of the buyers and will remain sold. **THERE SHALL BE NO RESALE OF THE HEIFERS BACK TO THE EXHIBITOR.** Montgomery County Fair Association will not act as an agent in the resale of the heifer. Buyers must pay for the heifers the day of the sale. The halter that the calf has on when it is sold becomes the property of the buyer.

23. All exhibitors who sell MUST HAVE THANK YOU LETTER(S) to their buyer, their receipt of delivery and their social security number to the Fair Office **WHEN CHECKS ARE RELEASED ON TUESDAY, MAY 25TH**. Only the exhibitor or the parent may pick up the check. **ALL CHECKS MUST BE PICKED UP BY MONDAY, JUNE 7TH BY 5:00 P.M. CHECKS NOT PICKED UP BY JUNE 7TH WILL BE FORFEITED AND THE MONIES WILL GO DIRECTLY TO THE FAIR SCHOLARSHIP FUND.**

24. The following scholarship money will be given:

- \$1,500 for First Place overall;
- \$1,000 for Second Place overall; and
- \$500 for Third Place overall

The scholarship money will be funded directly to the college, university or institution of higher learning of the exhibitor's choice upon satisfactory proof of enrollment. Scholarship must be used within one year from date of graduation of high school.

25. Entries must be completed and paid by **Friday, February 5, 2021 at 5:00PM** with a \$20 entry fee/hd.

JR. AND SR. SHOWMANSHIP WILL BE HELD AFTER THE SHOW AND IS OPEN TO ALL EXHIBITORS WHO WISH TO PARTICIPATE. YOU PAY \$5.00 (CASH) AT THE ENTRY GATE AND THE WINNER WILL BE AWARDED ALL PROCEEDS AT THE EXIT GATE. JR'S = 13 & UNDER, SR'S = 14 & OVER AS OF THE DAY OF THE SHOW.

6. A project can be exhibited only one time at the Montgomery County Fair and must have been completed within one calendar year of the exhibition date.
7. **Projects can be individually or group of (4) constructed and may be individually or chapter owned. All projects must be entered (in the maximum of 4 exhibitors) names of who participated in planning and construction of the project.**
8. Classes with less than four entries are subject to being combined.
9. Every precaution will be taken to protect the projects entered; however, neither the Montgomery County Fair nor the officials of this show will be responsible for any losses or damages to projects.
10. Appropriate and safe display stands must be provided for gates, panels, and other projects that need support. Sharp edges and points, such as found on self-feeder, roofs, bale movers, etc. are to be padded or covered as necessary to prevent injury.
11. All trailers and other projects to be towed on public roads must be registered and licensed and must meet current Texas Department of Transportation (TXDOT) regulations. A copy of registration is required at check-in.

12. There is to be no more than two gallons of fuel in any fuel tank. The fuel tank cap is to be in place and sealed with tape. The battery is to be disconnected. This applies to all engines in the exhibit area.
13. No "For Sale" signs may be placed on projects.
14. All judge's decisions and announced results will be final.

The Officers and/or Board of Directors reserves the right to amend or add to these rules as it, in its judgment, may deem advisable.

Any exhibitor and/or his or her representative who violates any of the General Rules or special rules as published in these rules will forfeit all privileges and premiums won.

In order to participate in the Montgomery County Fair, each exhibitor, and his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen and volunteers shall be in good standing with the Montgomery County Fair Association. In the event any exhibitor, exhibitor's immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen or volunteers (whether any of the above individually, or by, through and/or on behalf of any entity) owe money after August 1ST to the Montgomery County Fair Association for any reason whatsoever, said exhibitor, his or her immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen and volunteers shall not be allowed to enter, tag-in and/or participate in the Montgomery County Fair, Show and/or Auction.

THE FOLLOWING RULES AND REGULATIONS FOR ALL JR. NON-LIVESTOCK SHOWS HAVE BEEN ADOPTED BY THE BOARD OF DIRECTORS.

1. The Show will open April 10, 2021 unless postponed and/or canceled by the Officers and/or Board of Directors which they hereby claim the right to do, either in part or whole, due to any cause whatsoever which they determine to be for the general good of all concerned.
2. The Officers and/or Board of Directors reserves the right to amend, delete and/or add to these rules as they in their judgment, may deem advisable.
3. The Montgomery County Fair Association, its Board of Directors, Officers, Officer-in-Charge or Committeemen will not be liable for any personal injuries, damages, fire, theft, accident, etc.
4. Each exhibitor, exhibitor's immediate family member(s), parent(s), guardian(s) and/or representative(s), committeemen, judges, volunteers, spectators and/or visitors, violating and/or not cooperating with security personnel, officers, officer-in-charge, division chairmen, committeemen and/or officials of the Fair in all matters, policy, these rules and regulations, parking, etc., may not be allowed to enter, and/or participate; may have their entries cancelled, and/or may be ordered to exit and/or remove their exhibit(s) from the grounds immediately, and/or may forfeit all rights and privileges to enter, participate and/or exhibit in the future at the Montgomery County Fair.
5. Entrants and Exhibitors must be members in good standing of one of the following:
 - 1) FFA – must have attended 50% of local Montgomery County FFA Chapter from September through February.
 - 2) 4-H enrolled members must have attended a minimum of three (3) local Montgomery County 4-H Club meetings from September through February. This does not include project meetings.
 - 3) FHA – must be an active member in this school related club.
 - 4) Enrolled in a public, parochial or private school class during the entire current year, **which is related to the entry** (Example: Art Class, Photography Class, etc.). Must be 8 years old and in 3rd grade or 9 years old as of August 31, 2020 to enter.

5) May be a Home Educated Student but must be a member of a Montgomery County 4-H Club and subject to Rule 4. 2) above. Only Home Educated students, whom would have attended a private, public or parochial school in the county, are eligible to show.

Except as provided in GENERAL EXCEPTION (A) or (B) below, all Entrants and Exhibitors must reside in Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps in Montgomery County five or more nights each week) and must be enrolled and attending classes in private, public, parochial school or be a home educated student in elementary or secondary schools at time of registration.

GENERAL EXCEPTION (A): Any Entrant or Exhibitor who resides outside Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps outside Montgomery County five or more nights each week), but because of school district boundaries, student is required to attend public school inside Montgomery County, student must be a member in good standing and attended a minimum of 50% of club meetings of a Montgomery County 4-H Club or FFA.

GENERAL EXCEPTION (B): Any Entrant or Exhibitor who resides outside Montgomery County (Residence to mean student who lives with parents, parent or legal guardian and sleeps outside Montgomery County five or more nights each week), but because parents, parent or legal guardian is employed by a private, public or parochial school district or system in Montgomery County and the Entrant or Exhibitor is enrolled and attending classes in the same private, public or parochial school district or system in Montgomery County, student must be a member in good standing and attending a minimum of 50% of club meetings of a Montgomery County 4-H Club or FFA.

Any Entrant or Exhibitor who qualified under GENERAL EXCEPTION (A) or (B) above, may be allowed to participate by completing a Special General Exception Form, but only after official acceptance, which requires approval by the Montgomery County Fair Association. This form must be received in the Montgomery County Fair Office, P.O. Box 869, Conroe, Texas 77305 by **February 5, 2021**, if you are exhibiting Non-Livestock only. If you are exhibiting Livestock check division rules for due date of this form.

6. Any individual serving as Chairman, Assistant Chairman or Judge cannot allow his/her children to participate in the show in which he serves as Chairman, Assistant or Judge. Any individual serving as a committeeman (worker) cannot be present at the judging of the show in which he is working if his children are participating in that show, nor can he judge that show. **NO CHILDREN ALLOWED DURING JUDGING. NO TEACHERS OR LEADERS OF EXHIBITORS WILL BE ALLOWED IN THE AREA DURING JUDGING.**

7. Exhibits must be entered only by the individual making or creating it.

8. Previous entries (excluding foods) in the Montgomery County Fair are not eligible for re-entry.

9. No "For Sale" Signs may be placed on items during show or while on display.

10. Show Winner Recognition and Sale Placement Announcements:

a. Exhibitors may sell only ONE entry in the auction.

b. Exhibitors will be recognized for their show placement in Grand – 5th place. in each section/division and awards will be presented.

c. Final Sale Order will be announced IMMEDIATELY following the winner recognition.

d. IF an exhibitor has multiple entries in the Top Ten, they will be required to declare which item they prefer sell at auction by completing the Sale Item Confirmation Letter, provided by the committee prior to starting finals judging.

e. An exhibitor is NOT permitted to drop a Grand or Reserve Champion entry to sell an entry of lower sale placement.

f. In the event of an equal placement (2 Grand/Res. Champions) or if an exhibitor places 3rd – 5th with multiple entries, the aforementioned Sale Item Confirmation Letter will decide which item will be sold.

THE EXHIBITOR MUST BE PRESENT IN PERSON DURING THE AUCTION.

EXCEPTION: A substitute showman may be allowed if the individual is participating in the Market Barrow Show at the time of the Auction.

Junior Exhibitors who have a Grand Champion in the Junior Non-Livestock Show & Sale at the 2021 Montgomery County Fair will not be eligible to compete in that show, department, or division for the 2022 Montgomery County Fair.

11. Individual's wishing to compete in the Junior Non-Livestock Show must complete an online entry for EACH ITEM THEY WISH TO EXHIBIT. The item must be ENTERED AND PAID FOR by 5:00 p.m. on **FRIDAY, FEBRUARY 5, 2021** TO BE CONSIDERED CONFIRMED AND FINAL. NO LATE ENTRIES WILL BE ACCEPTED. An entry fee of \$10.00 per ITEM ENTERED will be charged – NO REFUNDS. SHOULD AN EXHIBITOR, CEA/VAT OR 4-H MANAGER FAIL TO GET AN ENTRY FORM IN BY THE ENTRY DUE DATE, A LATE FEE OF \$250.00 MAY BE ASSESSED. All exhibitors will receive an armband which entitles them free entry to the Fairgrounds from **April 9th – 11th, 2021**. There is a \$5.00 replacement fee for a lost armband.

12. All exhibits will be monitored, and every precaution will be taken to protect them, but in no case will the Montgomery County Fair Association be held responsible for loss, theft, breakage, or damage.

13. Exhibits will be judged and awarded Blue (Excellent), Red (Good), and White (Fair) Ribbons. At the discretion of the judges, finalist ribbons and honorable mention ribbons will be presented.

14. Articles not going to final judging or being placed on display must be picked up between 2:00 p.m. – 4:00 p.m. on Saturday, **April 10th** by presentation of Exhibitor's tag that will be issued at registration. Baked goods not picked up by 4:00 p.m. will become property of MCFA.

15. Special rules also apply for each of the following Junior Shows: Fine Arts, Photography, Horticulture, Home Economics, Needlecraft and Handicraft.

16. IT IS MANDATORY THAT EXHIBITOR BRING SOCIAL SECURITY NUMBER AND ORIGINAL THANK YOU LETTER(S) TO HIS/HER BUYER(S) TO THE FAIR OFFICE, AND THE FAIR OFFICE WILL MAIL THANK YOU LETTERS AND BUYER'S PICTURES. PARENTS AND/OR EXHIBITOR ONLY MAY PICK UP CHECKS AT FAIR OFFICE. FOREIGN EXCHANGE STUDENTS MUST ALSO HAVE A SOCIAL SECURITY NUMBER OR TAX I.D. NUMBER BEFORE CHECK WILL BE RELEASED. **CHECKS WILL BE RELEASED BEGINNING TUESDAY, MAY 25th. ALL CHECKS MUST BE PICKED UP BY MONDAY, JUNE 7th BY 5:00 P.M. CHECKS NOT PICKED UP BY JUNE 7th WILL BE FORFEITED AND THE MONIES WILL GO DIRECTLY TO THE FAIR SCHOLARSHIP FUND.**

17. Ten percent (10%) will be deducted from the Exhibitor's check for any and all monies received through the Fair Association. In addition, cost of pictures will be deducted from the Exhibitor's check.

18. For the **2021** Fair, it is expected that approximately 5 cakes from scratch, 5 cakes from mix, 5 cookies, 5 candies, 5 pies, 5 decorated cakes, 5 quick breads, 5 yeast breads, 5 canned foods, 5 Handicraft I, 5 Handicraft II, 5 Horticulture, 5 Needlecraft, 5 Fine Arts and 5 Photography for a total of 75 items to be auctioned.

19. An exhibitor removing his/her entry prior to 2:00 p.m. on Saturday, **April 10th** will automatically forfeit his/her ribbon. NO EXCEPTIONS.

20. An exhibitor cannot enter and/or sell an item in the Special Education Auction and in the Junior Non-Livestock Auction.

21. Exhibitor or one (1) member of the immediate family must bring and enter projects. No one else will be permitted into the Special Events Area.

22. If an item should win Grand, Reserve, 3rd, 4th or 5th place and the exhibit does not fit the dimensions of the display area or is structurally unstable, because of security problems, the item will not be displayed. Specific dimensions are listed for each show.

23. Should a family member purchase their own child's (whether by blood, marriage, adoption, foster child, exchange student, grandchild, ward, etc.) exhibit, said exhibit must be paid for before the exhibitor will receive his/her check from the Fair Office.

24. ANY EXHIBITOR WITH ANY SPECIAL NEEDS OR CONCERNS MUST PROVIDE WRITTEN NOTICE OF SAME TO THE FAIR OFFICE NO LATER THAN TWO (2) WEEKS BEFORE THE FAIR EVENT BEGINS SO THAT APPROPRIATE ARRANGEMENTS, IF ANY, CAN BE CONSIDERED.

25. All protests to any ruling and/or to any provision of these rules and regulations set forth from Page 33 to 51 must be in writing and be accompanied by a deposit of \$50.00 which will be forfeited if protest is not sustained. Such protest must state plainly the cause of complaint or appeal and must be delivered to the Fair Office and notice given to the Officer-in-Charge and/or Division chairman immediately after occasion for such protest. Judging procedures will not be interrupted for protest investigation. Depending on the basis of the protest, a decision may be withheld until complete investigation is done. All protests will be determined by a special committee made up of five members consisting of the Officer-in-Charge, Division chairman, and three other members from the rules committee and/or Board of Directors. Every exhibitor, in consideration of his entry being accepted by the Montgomery County Fair Association, agrees that the conclusion reached by the protest special committee shall be final, without recourse against the Montgomery County Fair Association, its Board of Directors, Officer-in-Charge, Division Chairmen, Committeemen, etc. (See General Provisions set forth on Pages 35-38).

 - In the Desserts and Breads Department's, you may enter ONE (1) item in each Division.
 - In the Canned Foods Department, you may enter ONE (1) item only.
3. Entries must be completed and paid by **Friday, February 5, 2021 at 5:00PM** with a \$10 entry fee per item.
4. All entries will be judged in the category in which it was entered by the exhibitor. After the entry deadline has passed, there will be no changes permitted to the entry. If you have questions about which department or division your entry should be in, please call the fair office for direction. If an entry was entered in the wrong department or division, it will only receive a white ribbon and will not be eligible for the Top 10 or Honorable Mention.
5. All entries WILL be tasted, with the exception – decorated cakes MAY be tasted. All ingredients are to be from scratch unless otherwise stated.
6. Grand Champion, Reserve Champion, 3rd, 4th and 5th in this division **will be required to have a duplicate of the winning entry to sell the night of the auction, EXCLUDING Decorated Cakes.**

7. NO PROJECT BOOKS WILL BE ACCEPTED WITH ENRIES.

JUNIOR HOMEMAKING SHOW ENTRY AND RECIPE SUBMISSION REQUIREMENTS

For the **2021** Fair, you will submit all recipe's and log-sheets (IF REQUIRED) **THE DAY OF THE SHOW ONLY** when your entry is turned in.

1. Each entry recipe will be accepted in the following format:
 - A. Hand-written or typed on 3x5 index cards, front only (do not write on the back); multiple cards may be used.
 - B. All recipes (and log sheet if applicable) must be stapled in the top left-hand corner.
 - C. If you do not turn in a recipe and/or log sheet if applicable, the day of the show, your entry will not be judged.
 - D. THE RECIPE SUBMITTED BECOMES PROPERTY OF THE MCFA AND WILL NOT BE COPIED OR RETURNED TO THE EXHIBITOR UNTIL COMPLETION OF THE JUNIOR HOMEMAKING SHOW. IF IT IS NOT PICKED UP AFTER THE SHOW, IT REMAINS THE PROPERTY OF MCFA AND WILL BE DESTROYED.

DEPARTMENT: DESSERTS

DIVISION: CAKES FROM SCRATCH

- No pre-packaged mixes can be used in the cake or topping.
- Presentation for cakes, cupcakes and cake balls:
 - Must be on a stiff, disposable surface that is covered with aluminum foil.
 - Professional pre-made boards must be covered with aluminum foil.
 - The stiff surface should not exceed the dimensions of the cake by more than 3" on all sides.
 - Item must be covered with a clear transparent wrap.
- Cake balls and cupcakes will be accepted; however, all must be of the same recipe and decoration.
- Cheesecakes will be accepted as long as it does not require refrigeration.
- NO ENTRIES REQUIRING REFRIGERATION WILL BE ACCEPTED IN THIS CATEGORY.

DIVISION: CAKES FROM MIXES

Recipe must include:

- Type of cake mix and topping used as base in recipe.
- Any additional ingredients added to complete the cake and topping.
- All mixing and baking instructions; any additional preparation instructions.
- Presentation for cakes, cupcakes and cake balls:
 - Must be on a stiff, disposable surface that is covered with aluminum foil.
 - Professional pre-made boards must be covered with aluminum foil.
 - The stiff surface should not exceed the dimensions of the cake by more than 3" on all sides.
 - Item must be covered with a clear transparent wrap.
- Cake balls and cupcakes will be accepted; however, all must be of the same recipe and decoration.
- NO ENTRIES REQUIRING REFRIGERATION WILL BE ACCEPTED IN THIS CATEGORY.

DIVISION: DECORATED CAKES

- Cake must be fresh and consumable at the time of judging as items may be cut and may be tasted.
- All parts must be 100% edible. (EXCEPTION: supports such as columns, toothpicks, etc.)
- Presentation for decorated cakes:
 - Must be on a stiff, disposable surface that is covered with aluminum foil.
 - Professional pre-made boards must be covered with aluminum foil.
 - The stiff surface does not exceed the dimensions of the cake by more than 3" on all sides.
 - Cakes must not exceed 36" x 36".
 - Do not cover.

Dropped, Rolled, Pressed, Bars, Molded, Refrigerator or Miscellaneous:

- Brownies are included in this section.
- Store-bought cookies, in any form (crushed, blended, etc.) may not be used as an ingredient in this section (Example: Oreos, Vanilla Wafers, Graham Crackers, etc.).
- No pre-packaged mixes may be used as an ingredient.
- Presentation for cookies:
 - Must be on a 12" maximum stiff, disposable surface covered in aluminum foil.
 - Must consist of enough pieces to properly fill the surface.
 - Item must be completely covered with clear transparent wrap for turn-in.

DIVISION: CANDY

Fudge, Divinity, Brittle or Miscellaneous:

- MUST NOT CONTAIN FLOUR
- No pre-packaged mixes may be used as an ingredient.
- Presentation for candy:
 - Must be on a 12" maximum stiff, disposable surface covered in aluminum foil.
 - Must consist of enough pieces to properly fill the surface.
 - Item must be completely covered with clear transparent wrap for turn-in.

DIVISION: PIES

Pies in Crust, Fried Pies and Pie Tarts (individual or single):

- No pre-packaged mixes may be used as an ingredient.
- All crusts must be made from scratch, recipe to be included.
- Presentation for pies:
 - Pies in crust must be in a foil pie pan approximately 9" in diameter.
 - Fried pies must be on a 12" maximum stiff, disposable surface covered in aluminum foil.
 - Must consist of enough pieces to properly fill the surface.
 - Single tart must be baked in approximately 9" tart pan and placed on a 12" maximum stiff, disposable surface covered in aluminum foil.

- No prepackaged mixes may be used as an ingredient.
- Presentation for breads:
 - Entry must be on a stiff, disposable surface covered by aluminum foil; surface cannot exceed the dimensions of the entry by more than 3" on any side or corner. Item must be completely covered with clear transparent wrap for turn-in.
 - Professional pre-made boards must be covered with aluminum foil.

DIVISION : YEAST BREADS

Loaf, Plain Rolls, Sweet Rolls, Fancy Breads or Miscellaneous

- MUST CONTAIN YEAST
- Must be made by hand, no bread machines.

- Presentation for breads:

All entries must include processing and canning instructions with the recipe.

All entries must be processed in a canner or hot water bath, whichever is applicable.

MCFA Log Sheet is required for all canned foods from scratch.

SECTION A. VEGETABLES AND FRUITS

LEAFY VEGETABLES AND CABBAGE AND THEIR RELATIVES

- Chard Collards, Lettuce, Broccoli, Cabbage, Cauliflower, etc.
- Two heads or bunches on an oval (platter type) paper plate –
- Outer leaves should be removed, stems cut clean, leaf bunches tied together and should have roots removed.

ROOT CROPS

Beets, Carrots, Green Onions, Shallots, Radishes and Turnips

- Two standard bunches of 4 to 6 roots per bunch on a paper plate.

FRUITS AND FRUITING VEGETABLES

Peas, Strawberries, Blackberries and Dewberries

- Small fruits and vegetables consisting of 8 to 10 items of uniform color and shape on a paper plate
- Large fruits and vegetables consisting of 4 to 6 items of uniform color and shape on a paper plate.

SECTION B. HORTICULTURE - CONTAINER PLANTS

African violets, Foliage plants, Ferns, Cactus and other succulents, etc.

TERRARIUMS, HANGING BASKETS, CUT FLOWERS

Annuals, Perennials, Collection of flowers

- 3 stems

TREE AND SHRUB BRANCHES

- Each Single branch must be 14" – 36" Long
Flower of fruiting, Broadleaf evergreen, Needled evergreen, Decorative foliage

NO SILK OR PLASTIC

- All fresh material
- Dried and fresh material
- All dried material

COUNTRY STORE RULES

1. You must have paid an entry fee, ENTERED and PARTICIPATED in competition in the Adult Non-Professional Division of the Montgomery County Fair for the current year. Failure to do so will result in forfeiture of income and eligibility to participate in future shows and items will be pulled from the Country Store. A participating 4-H or FFA group with exhibitors in the current Montgomery County Fair may sell their items in the Country Store. Clubs must enter items as a "group" and not as individuals.
2. You must enter for sale those items listed in the official Montgomery County Fair Catalog rules for Non-Professional Adult Shows and Jr. Non-Livestock Shows for the current year. Other items may be sold with prior approval of Show Chairman.
3. Canned products are to have been prepared within the last year only. The jar must be clean and labeled on the side of jar as to the contents and the date it was preserved. The lids and rims must be standard and free of rust. All jars must be sealed.
4. All baked items must be labeled and dated. Any perishable baked goods not sold or picked up may be discarded at the discretion of the Country Store Committee.
5. No used or damaged articles will be accepted. All merchandise must have been made in the last year. Items entered in the Country Store last year which did not sale, may not be re-entered.
6. Other additional items to restock may be brought in daily 30 minutes before doors open. **ONCE DOORS OPEN, YOU MAY NOT RESTOCK UNTIL THE FOLLOWING DAY. SATURDAY MORNING, APRIL 17th WILL BE THE LAST TIME TO RESTOCK.**
7. Twenty percent (20%) of the sale price will go to the Montgomery County Fair Association. Checks less the 20% and sales tax will be mailed to Seller or group within thirty days. Payments will be made only on those items for which the Country Store has a yellow tag.
8. Participants may come by the Fair Office the week of **Monday, March 29th – Friday, April 2nd, 2021** to pick up seller number, sale tags and sale cards.
9. Items must be tagged and brought to the Country Store Thursday, **April 8th** between 4:00 p.m. and 7:00 p.m.
10. All items not sold must be picked up no later than **Sunday, April 18th between 2:00PM & 5:00PM.** Items not picked up will become the property of the Montgomery County Fair Association. **NO EXCEPTIONS.**
11. The County Store Committee reserves the right to reject any item that does not qualify or is in bad taste.
12. All items for sale must be created by the seller and no commercially packaged items will be accepted, unless items are donated, and Montgomery County Fair Association receives 100% of the proceeds. Commercial Exhibitors will be allowed to enter items for sale in the Country Store if they meet the guidelines of the Non-Professional Adult Show rules.
13. Sale items must have a yellow sale tag attached with the following information:
 - 1) Seller's name and address
 - 2) Name of item
 - 3) Sale Price

14. Sale cards must have a numerical list of all items with the same number as the yellow sale tags. Sale cards MUST be completed before items are checked in.

15. No item shall be priced under \$1.00 and must be in increments of 50 cents. All items must be priced to include sales tax. MCFA will report all sales and pay appropriate sales tax on items sold.

16. All precautions will be taken; however, the Montgomery County Fair Association will not be responsible for items lost, damaged or stolen.

17. The Country Store Committee will accept donated new handmade items, will price those items and the entire sale will go to the Montgomery County Fair Association.

18. THE COUNTRY STORE COMMITTEE RESERVES THE RIGHT TO DISPLAY OR STOCK ITEMS AT THEIR DISCRETION.

19. The Country Store will be staffed by Committee members and volunteers.
