## JR LIVESTOCK AUCTION - 2024 TERMS

Wednesday, April 17 @ 6:30 pm  
Lone Star Convention Center

**BIDDING:** All animals sell to the highest bidder. Any disputes or questions regarding bids will be settled by the Auctioneer and their decision will be final.

**BUYER NUMBERS:** All buyers must be registered and have an assigned number to bid. Recognition to the preregistered buyers can be given to the name corresponding with the buyer's number.

**BUYER GROUPS/BROWN FORMS:** Buyers wishing to buy in combination with others need to register as a group and receive a specific buyer number for the group. Buyer Group Forms (Brown Forms) are only valid if your group is the winning bidder. This form cannot be submitted as an add-on to any sale order. The buyer turning in the Brown Buyer Form at the Auction must sign it and accept responsibility for all contributions listed on the form. Please make sure this form is completed before handing them to the ring man.

**BUYER RECOGNITION:** In cases where groups exceed four (4) individuals or business names, it is understood that only the top four (4) listed will receive public recognition. Pictures can include all buyers.

**CONTRACT OF SALE, DISPOSITION & RECEIPT OF DELIVERY:** Buyer must sign a completed Contract of Sale & Disposition of Animal Form including paddle #, name, phone #, purchase price and disposition immediately after the Sale Order animal is won. If no disposition is on the ticket, MCFA management will complete the contract disposition as they deem necessary.

**PAYMENT:** BUYER MUST MAKE PAYMENT IN FULL DIRECTLY TO THE MONTGOMERY COUNTY FAIR ASSOCIATION UPON RECEIPT OF INVOICE. DUE DATE FOR PAYMENT IS FRIDAY, MAY 31, 2024.

**ADD-ON MONIES:** Add-On Forms will be available at the Auction and on mcfa.org. Completed forms and payment may be turned in the night of the Auction at the center exit. Otherwise, they must be received in the Fair Office no later than the Friday after the Fair ends – April 26<sup>th</sup> by 5:00pm.
